### **NSF Progress Reports**:

- Be sure to use the Interim Project guidelines, not "interim and final" guidelines.
- Confirm that individuals are not working on the NSF project but paid by another federal award

Federal Register Notices on Interim Research Performance Progress Reporting

#### What individuals have worked on the project?

Provide the following information for: (1) principal investigator(s)/project director(s) (PIs/PDs); and (2) each person who has worked at least one person month per year on the project during the reporting period, regardless of the source of compensation (a person month equals approximately 160 hours of effort).



## **NSF Updates**

The new <u>PAPPG</u> will be effective for **proposals submitted**, or due, on or after January 29, 2018. Significant changes include:

- Implementation of the standard Collaborators and Other Affiliations (COA) template that has been in pilot phase since April
  \*NOTE\* information requested in prior versions of the PAPPG is no longer requested
- **Project Description**: must contain "Intellectual Merit" section
- Budget Justification: increased page limit to five pages
- Senior Personnel Salaries & Wages Policy: definition of "year" tbd
- Indirect Costs: should be specified in justification
- Data Management Plan: additional guidance on content





### November/December NSF newsletter is available

- Coming Spring 2018: Revised account management will consolidate multiple NSF User logins to a single user login
- April 2018: prepare and submit non-collaborative proposals in Research.gov, running in parallel with Fastlane
- Public Access Policy: ensure articles in peer-reviewed papers are easily available in public access compliant repository





NIH Statement on Article Publication Resulting from NIH Funded Research November 3, 2017 NOT-OD-18-011

- To protect the credibility of published research, authors are encouraged to publish papers arising from NIH-funded research in reputable journals
- Avoid publishing in journals that do not have a clearly stated and rigorous peer review process
- NIH encourages publishers to follow established industry best practices
