### Research.gov: New Functionality

- Use of proposal submission function (for non-collaborative proposals) begins April 30
- NSF is asking users to test now in Production all the way to submission
  - System is in test-mode only- submission is not live
  - ORA is testing Reseach.gov
- Great news:
  - Easy to navigate
  - Validations on the fly.
- Other Authorized User (OAU) role is a helpful fix for department admins
- Come April 30, 2018, all testing data in the Production system will be wiped out
- Collaborative proposals are not part of the April 2018 launch, but will be in a subsequent launch

### NSF Account Management System

- Effective March 26, 2018, NSF is introducing a new centralized and streamlined account registration process in Research.gov that will:
  - Provide each new user with a single profile and unique identifier (i.e., NSF ID) for signing in to FastLane and Research.gov for proposal and award activities.
- **New Functionality** will:
  - Allow users to create and self-manage accounts, including personal information and role requests;
  - Eliminate the need for organizational Administrators to create accounts and maintain profile information for their users, allowing Administrators to focus on managing roles for their organizations through a dashboard with functions to approve, disapprove, assign, and remove roles; and
  - Replace the existing FastLane and Research.gov account management functions.

### Proposal Prep & Award Reminders

- 2018 Executive Level II Salary Cap is \$189,600 (<u>NOT-OD-18-137</u>)
- **Consultants** included in proposal/award budget:
  - NIH SF424 Guide section G.400:

For consultants, letters should include rate/charge for consulting services and level of effort/number of hours per budget period anticipated. In addition, letters ensuring access to core facilities and resources should stipulate whether access will be provided as a fee-for-service.

• NSF PAPPG Chapter II.C.2(g)(vi)(c):

and when not contingent upon recovery of costs from the Federal government. Anticipated services must be justified and information furnished on each individual's expertise, primary organizational affiliation, normal daily compensation rate, and number of days of expected service. Consultants' travel costs,

• Font Size: NSF Proposals

#### **Proposal Margin and Spacing Requirements**

The proposal must conform to the following requirements:

a. Use one of the following typefaces identified below:

• Arial, Courier New, or Palatino Linotype at a font size of 10 points or larger;

Times New Roman at a font size of 11 points or larger; or

Computer Modern family of fonts at a font size of 11 points or larger.

- Updated:
  - AOS Form
  - UPAF Form, now called the "Transaction "Form
  - fCOI Form
- Added a new How-to Guide for the Transaction Form
- Available as of today on the website
- Go live for use April 1, 2018
- Remember, these forms are temporary until ePAWS goes live
  - Purpose of changes is to facilitate understanding of the flow ePAWS will likely have
  - To clarify and streamline
