NSF Updates

- Effective October 5, 2020, the National Science Foundation (NSF) will begin enforcing the
 <u>Proposal & Award Policies & Procedures Guide</u> (PAPPG) (NSF 20-1) requirement to use NSF approved formats for the preparation of the Biographical Sketch and Current and Pending
 Support proposal documents
 - The NSF-approved formats are <u>SciENcv: Science Experts Network Curriculum Vitae</u> and an NSF fillable PDF
- Beginning on October 5, 2020, links to the <u>Biographical Sketch</u> and <u>Current and Pending Support</u> websites will also be located in FastLane (on the Biographical Sketch and Current and Pending Support Personnel pages), in Research.gov (on the Biographical Sketch and Current and Pending Support Upload pages), and in Grants.gov (on the NSF Senior Key Person Profile form version 2.0).

- When editing a record, only edit in one window
 - Multiple windows open editing the same record creates errors in saving data to the database

- Retro salary adjustments will be calculated at the new rate even if for a prior pay period
- Campus rates remain the same at 31.9%

• Expiring flexibilities of OMB M-20-26 relating to salaries and other expenses on Sept 30:

"Awarding agencies may allow recipients to continue to charge salaries and benefits to active Federal awards consistent with the recipients' policy of paying salaries (under unexpected or extraordinary circumstances) from all funding sources, Federal and non-Federal."

Research Development Faculty Support



1. Find funding opportunities (internal and external)



2. Build topical teams



3. Navigate administrative structures within institution



4. Prepare proposals (editing and/or project management)



5. Connect to Funders



Central Research Development Support

- 1. Coordination with Regional Campuses, Colleges, Institutes
- Internal seed grant programs (including joint programs with other institutions)
- 3. Convene faculty around major submission opportunities, both current and anticipated
- Coordinate assistance for major proposals, sometimes in conjunction with TIER 2 consultants
- 5. Coordinating Limited Submissions
- Curation and targeted dissemination of early career opportunities (many of which are non-federal and involve Corporation/Foundation Advancement)



Proposal Development Support

Research Development can provide support in coordination with college level resources:

- 1. Identification of funding opportunities
- 2. Organizing and convening around topical areas of interest and targeted opportunities
- 3. Connecting Faculty to other relevant internal and external resources

For Large, Complex, and Highly Visible Proposals:

- 1. Organize an internal kickoff meeting to discuss administrative support (Timeline, FOA Breakdown, etc)
- 2. Facilitate team organization and meetings
- 3. Advise on internal Tier program support
- 4. Provide additional support in coordination with broader university and college resources



Internal Grants

Research Development administers a variety of internal grant programs:

- TIER 1 Award Program (15-month awards, yearly submission cycle)
- TIER 2 Award Program (rolling basis)
- TIER 3 Award Program (rolling basis)
- NU/Dana Farber Cancer Institute Awards (12 month awards, yearly submission cycle)
- Roux/UMaine seed grant program

Submission and Award Management:

- Award submissions are submitted by faculty, directly to our office or our TIER 1 submission platform, and are not run through ePAWS, except for rare instances
- Award accounts are managed in the PI's home department, with the assistance of their department finance manager
- Pls are responsible for submitting required reporting
