NU-RES Admin Updates

- FCOI review Standard Operating Procedure (SOP) updated.
 - New! Reviews at NCE stage will only be as required by funding agency.
- Coming Soon!
 - Guidance: Distinction between Sponsored Award Activity and Service Agreement contracts
 - Guidance: Non-NU personnel as Co-PIs
- NIH Operates Under a Continuing Resolution NOT-OD-22-009
 - Continues government operations through December 3, 2021 at the FY 2021 enacted level, with no reduction.
 - Institutes and/or Centers may, at their discretion, issue non-competing research grant awards at a level below that indicated on the most recent Notice of Award.
 - Upward adjustments to awarded levels will be considered after FY 2022 appropriations are enacted,





NU-RES Finance Updates

- NSF Site Visit March 2022
 - Communication to ADFs and ADRs as an FYI
 - More detail as they become available
- F&A Negotiations this FY
 - Currently under a provisional rate
 - Different than in previous years
 - Will communicate changes as they come
- Workday Go Live
 - HR Virtual ILT will be held **between Monday, Nov 15, and Friday, Nov 19**, with a few exceptions for University and Local HR
 - Workday Time Tracking SPT available for University and Local HR starting Monday, Nov 22
 - Cut over period for PDCs, more to come

System Updates

- New eCLAWs Funded Agreement types NCE
 - Introduced to streamline NCE process; highlights for Reviewers, and reduces questions to only those needed, including providing Banner Grant number
 - New Types:
 - Funded Agreement Industry NCE
 - Funded Agreement Contract NCE
 - Funded Agreement All Others NCE
- In Development:
 - Method to capture affiliations in ePAWs while not disrupting Credit Split
 - Method to capture additional Special Reviews (e.g. CUI, CMMC) at time of award
 - Capturing/reporting on CUI will help colleges to ensure compliance when students or post docs are moving in between projects
 - Work with ITS to bring new Special Review categories to Data Warehouse
