NSPM-33 Research Security Program

- January 2022, the government released "Guidance for Implementing National Security Presidential Memorandum 33 (NSPM-33) on National Security Strategy for United States Government-Supported Research and Development"
 - Set forth the requirement that <u>institutions receiving more than \$50 million per year in federal research funding must stand up a research security program by the time the guidance is implemented</u>
 - Required elements: cyber security, foreign travel security, insider threat awareness and identification, and export control training.
- February 2023, Office of Science and Technology Policy (OSTP) released a draft Research Security Programs Standard Requirement document
 - Included some additional requirements related to the research security programs guidance
 - Draft is still open for public comment; hope to get finalized guidance later this year






Required Components

- Cybersecurity
 - Apply basic safeguarding protocols and procedures; CMMC security requirement are separate and distinct from these.
- Foreign travel security
 - Policies that include an organizational record of covered international travel by faculty and staff and, as appropriate, a disclosure and authorization requirement in advance of international travel, security briefings, assistance with electronic device security (smartphones, laptops, etc.), and preregistration requirements.
- Research security training
 - Provide training to relevant personnel on research security threat awareness and identification, including insider threat.
- Export control training
 - Research organizations conducting R&D that is subject to export control restrictions should provide training to relevant personnel on requirements and processes for reviewing foreign sponsors, collaborators and partnerships, and for ensuring compliance with Federal export control requirements and restricted entities lists.
- Digital Persistent Identifiers (DPIs)
 - Incorporate into disclosure process to bolster research security and integrity while reducing administrative burden.
