Why are the documents needed?

- When applying for funding, agencies want to know:
 - What other commitments an investigator has or may have at the time of award
 - determines if there is commitment, budgetary, or scientific overlap with other research endeavors
 - Whether the investigator is qualified to conduct the proposed research
 - Whether there are any collaborations they may have with other researchers who may be chosen to review applications so as to eliminate any conflicts

How can we help?

- As grant administrators, we help our investigators collect and combine the information required by the funding agency for a successful submission
 - What needs to be included in the proposal's support documents
 - What resources are available to help pull it all together?

- Principal investigator (PI), co-PI, trainee, researcher, post-doctoral student, or Administrator cannot create their own eRA Commons account
 - Only a signing official or other administrator at the institution can create an account
- Submit a request to NU-RES to register for an eRA Commons ID



 NU-RES will create the account, and assign the appropriate roles based on the request





A. Personal Statement

I am an Associate Professor of Psychology, and my research is focused on neuropsychological changes associated with substance use disorders. I have a broad background in psychology, with specific training and expertise in ethnographic and survey research and secondary data analysis on psychological aspects of substance use disorders. As PI or co-Investigator on several university- and NH-funded grants, I laid the groundwork for the proposed research by developing effective measures of disability, depression, and other psychosocial factors relevant to older people with substance use disorders, and by establishing strong lies with community providers that will make it possible to retruit and track participants over time as documented in the following publications. In addition, I successfully administered the projects (e.g. staffing, research projections, Indgef1, collaborated with other researchers, and produced several peer-reviewed publications from each project. As a result of these previous experiences, I am aware of the importance of frequent communication among project members and of constructing a realistic research plan, timeline, and budget. The current application builds logically on my prior work. During 2015-2016, my career was disrupted due to family obligations. However, upon returning to the field, I immediately resumed my research projects and collaborations and associately competed for NH support. However, because many older adults were raised during an era of increased drug and alcohol use. there are reasons to believe that this will become an increasing issue as the population ages. By providing evidence and simple clinical approaches, this body of work has changed the standards of care for older adults with substance use disorders and will continue to provide, assistance. in relevant medical settings well into the future. - Must be provided for each individual identified as senior or key project personnel.
- NSF required template must be used and not altered.
- Information includes:
 - Individuals name & organizational affiliation (last 12 months)
 Personal, family, or business relationships
 Ph.D advisors and all Ph.D. thesis advisees
 Co-authors and collaborators (last 48 months)
 Editorial board, editor-in chief, and co-editors (last 24 months)

NIH Other Support Policy

- NIH will continue to use the MS Word Form. implementation of the Current and Pending (Other) Support Common Form developed by the National Science and Technology Council's Research Security Subcommittee is planned in January 2025.
- Required from all senior/key persons on the proposal.

- Other Support includes all resources made available to a researcher in support of and/or related to all of their research endeavors, regardless of whether or not they have monetary value and regardless of whether they are based at the institution the researcher identifies for the current grant.
- Other support does not include training awards, prizes, or gifts. Gifts are resources provided where there is no expectation of anything (e.g. time, services, specific research activities, money, etc.) in return.
- Supporting documentation of foreign appointments and/or employment with a foreign institution for all foreign activities and resources that are reported in Other Support.
- Immediate notification of undisclosed Other Support as soon as it becomes known.

Completing the Department of Energy (DOE) Other Support Document



Department of Energy Other Support

- The majority of DOE and NASA program offices require current and pending support disclosures, but there are variations regarding the type of information that must be included in the disclosures.
- Standardizing disclosure requirements is a central theme in the NSPM-33 implementation guidance, and federal research agencies are charged with developing model financial assistance application forms and instructions.

- The information may be provided in the format approved by the National Science Foundation (NSF), which may be generated by the Science Experts Network Curriculum Vitae (SciENcv).
- The use of a format required by another agency is intended to reduce the administrative burden to researchers by promoting the use of common formats.
- In addition to current and pending support, DOE/NNSA program offices may also require disclosure of past support. This should be limited to a reasonable time period (e.g., previous five years), to be determined by the DOE/NNSA program office.




Current and Pending (Other) Support Best Practices

- If unsure whether something needs to be disclosed, in the interest of full transparency, err on the side of disclosure.
- Ensure to read agency-specific instructions when preparing Other Support. Requirements may differ depending on the agency.
- Investigators on *research* projects, regardless of whether they receive salary support from sponsor, must devote measurable effort.
- For NU investigators who are on an academic appointment, summer effort across active support cannot exceed 3.2 months in any year.
- NSF / NIH Effort for the current budget period and subsequent budget periods need to be reported. Effort provided in prior years does not need to be included.
- NIH Other Support needs to be electronically signed (see next slide)

<u>Current and Pending (Other)</u> <u>Support Common Form developed</u> <u>by the National Science and</u> <u>Technology Council's Research</u> <u>Security Subcommittee (NSPM-33).</u>

- Two Federal agencies released implementation dates, with two more acknowledging that they will incorporate the new requirements into their policies and procedures at some point in the future.
- NSF implemented for proposals submitted on, or after, May 20, 2024, using SciENcv
 - While form instructions says the ORCID of the senior/key persons is optional, that is a FORM rule; NSF will likely make it a mandatory field in the near future
- NIH will implement the new requirements in January 25, 2025 (FORMS-I) using the standard templates released with the requirements. They will then transition to SciENcv, to align with NSF, in May 2025.
 - NIH retired the eRA Commons Quick Queries page on June 3, 2024 – same data on a person's organization is available in eRA Commons
- NASA announced they will incorporate the new requirements into their Grants Policy Manual, but no date is set yet.
- DOE is currently negotiating with OSTP to implement the new requirements.
