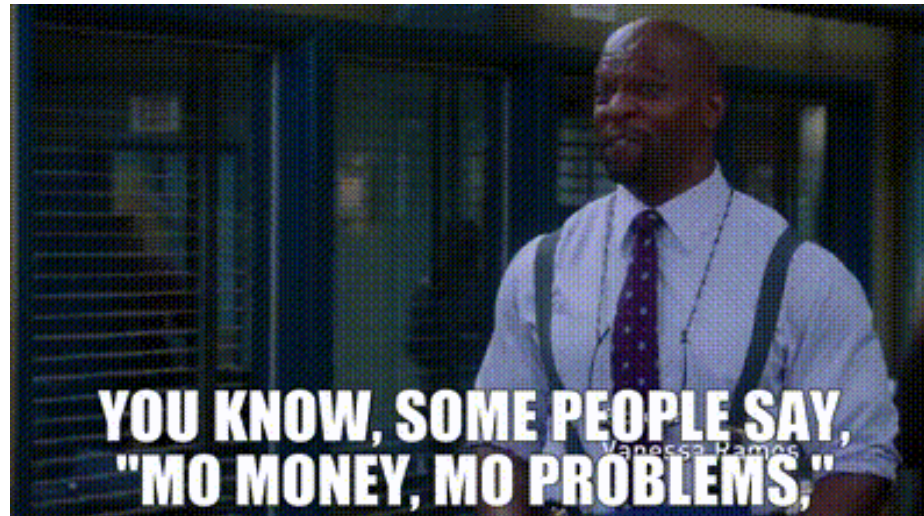

- [NOT-OD-25-085](#): Guidance on Salary Limitation for Grants and Cooperative Agreements FY 2025
 - Effective January 1, 2025, salary limitation for Executive Level II is \$225,700



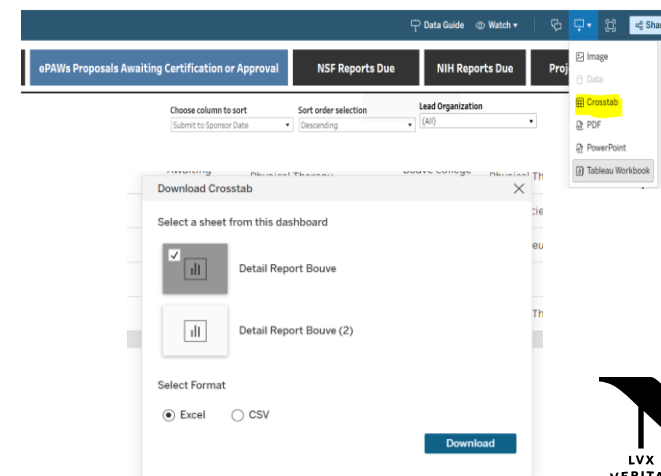
Data/Systems Updates

Downloading Data from Tableau Server to Excel example:

- Use the highlighted option from the ribbon to export data.

 - Select the sheet:
 - Detail Report Bouve: Where Lead is Bouve.
 - Detail Report Bouve (2): Current stop person is Bouve.
 - Select Format: Excel for export.

Data/Systems Updates

- Deobligations in eCLAWs
 - If you get a deobligation of a contract, the current process is to submit a new eCLAWs record with the deobligation as a negative number

RESEARCH & INNOVATION FUNDED AGREEMENT - CONTRACT

- We anticipate getting back to eCLAWs enhancements this year, and are queuing up "Amend or Modify a Contract or Agreement" functionality...until then, a negative number can be inserted
- New Process/Stop in eCLAWs route: Adding OGC stop
 - When the NU-RES Reviewer requires review by OGC, they will now insert a new OGC Review stop to the workflow – Status will change to OGC Review, resulting in greater transparency into the status of the agreement

Data/Systems Updates

- Updates to the Metrics, Measures & Indicators (MMI's) on the homepage
 - All MMI dashboards have been transitioned from a static data source to a dynamic connection
 - **MMI's are now embedded Tableau dashboards directly into the website**, enabling real-time information which will be updated automatically based on our scheduled refresh cycle



Once on the Tableau dashboard, navigate to the other MMI's by the tabs, or select the down arrow on the left and pick an MMI

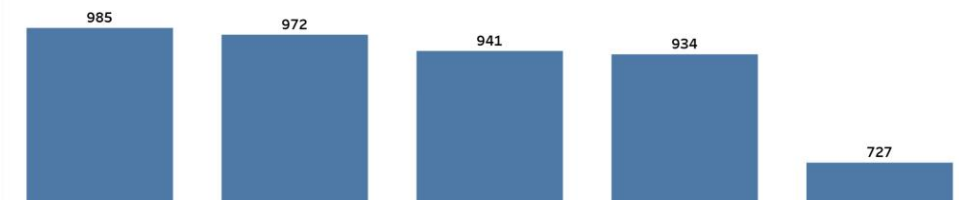

NU-RES Compliance Updates

- Reminder that the Annual Disclosure Cycle, collecting information from the 2024 Calendar Year, is now live.
 - You can access your disclosure application [here](#). Disclosures are required for all faculty and staff; students are exempt from this process.
 - Prior to submitting your disclosure, please review Northeastern University's policies on [Conflicts of Commitment](#) and [Financial Conflicts of Interest](#), as well as the [Policy on External International Engagements](#).

NU-RES Compliance Updates

- Friendly reminder as summer is around the corner - review the [Policy on External International Engagements](#). Key points:
 - Recognizes the potential for COI or COC, and national security and compliance concerns related to certain int'l engagements
 - Foreign Talent Recruitment Programs (FTRP) vs. Malign Foreign Talent Recruitment Programs (MFTRP)
 - Requirement for all primary faculty to seek prior approval before beginning any external int'l engagement
 - To obtain approval, the faculty member must submit a copy of any contract or agreement defining the parameters of the international engagement and complete the [International Engagement Intake form](#)

NU-RES Compliance Updates

Foreign Travel Requirements:

- Register travel with the [Travel Registry](#) - if you book through Concur, the trip is automatically registered
- Travel to high-risk countries may require a research security review, export control review, and/or a travel briefing (i.e., loaner devices, cybersecurity, best travel practices)
- Supervisor approval is required for travel to high-risk countries

NU-RES Compliance Updates

- Research security training requirements mandated by the [Department of Energy \(DOE\) Financial Assistance Letter \(FAL 2025-02\)](#) and the new requirements outlined in the [Department of Energy's \(DOE\) Financial Assistance Letter \(FAL 2024-05\)](#) regarding Digital Persistent Identifiers (DPIs) or Persistent Identifiers (PIDs) for all R&D financial assistance awards.
- Page 3, Section C: Implementation
 - DOE's Financial Assistance Certifications and Assurances with Use SF 424 will require Grant Officers to certify that:
 - "The applicant certifies to the best of its knowledge and belief that each covered individual who is employed by the applicant and listed on the application has **completed a research security training program** consistent with Section 10634 of the CHIPS and Science Act of 2022."

NU-RES Compliance Updates

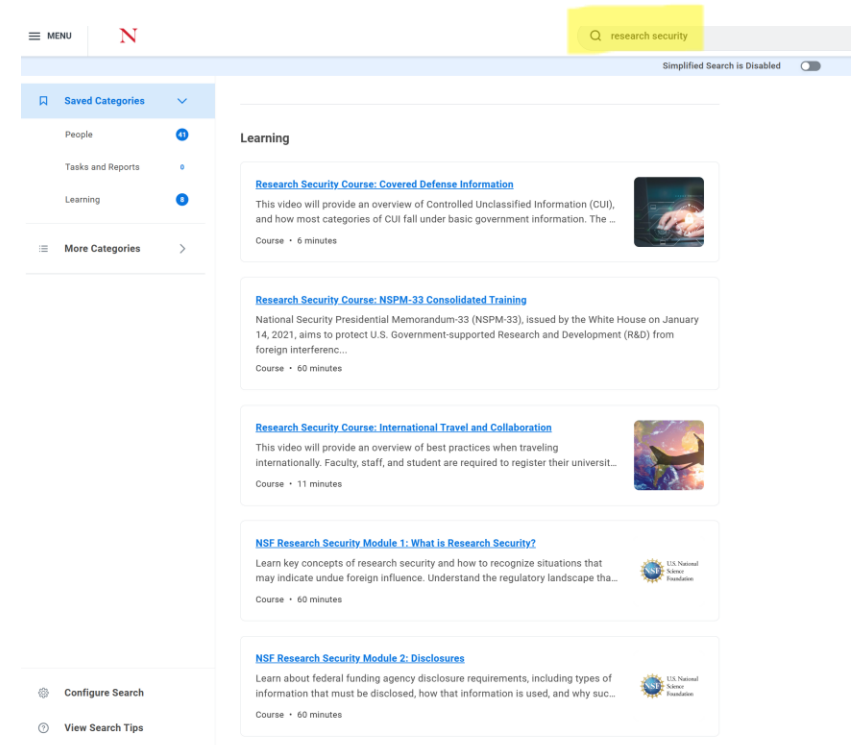
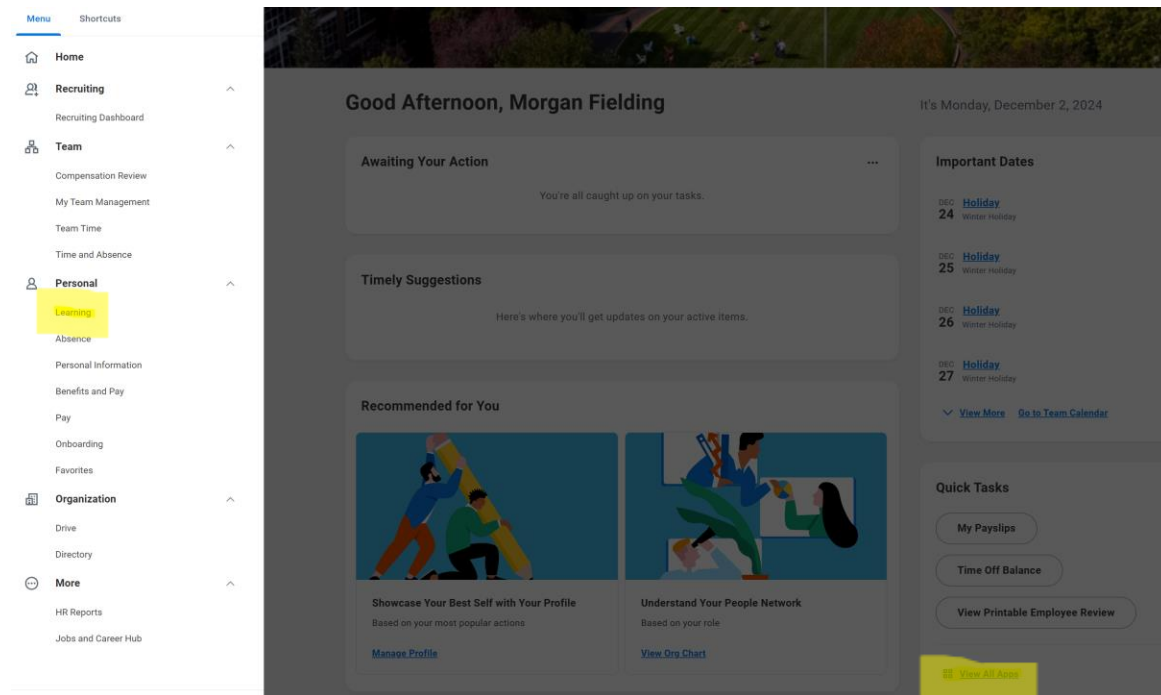
- These requirements become mandatory beginning **May 1, 2025** for all individuals involved in DOE-funded research projects or submitting applications to the DOE.
 - "Any new covered individuals at the recipient and subrecipient levels added to the project must certify that they have completed the training within thirty (30) calendar days of the individual joining the project". Certification for covered individuals that they have completed mandatory RS training will be collected via an additional certification on the Current and Pending (Other) Support disclosure."
- All research security training will be completed through Workday Learning. NU has loaded the 4 accepted NSF trainings into Workday Learning as well as the combined NSF funded module.
 - The module that will be used for the mandatory training is the [NU-RES Research Security Course 1: Foundations of Research Security](#). Others will be used for refresher training.

NU-RES Compliance Updates

- Research Security Training Communications:
 - All PIs who have active DOE prime awards, subawards, or have submitted proposals to DOE were contacted regarding the RS Training requirement via email in March. A follow-up communication was sent to the respective administrators (primarily COE, COS, and Khoury).
 - We may not have reached everyone! Please ensure any Co-PIs, Program/Project Managers, Senior/Key Personnel, and those with similar roles or significantly contribute to DOE funded research are assigned and complete the training.
 - Workday Learning training module was assigned by April 1.
 - Department and college grant administrators should periodically check-in with their faculty regarding completion status. We will follow-up before the May 1 requirement date.

NU-RES Research Security Course 1: Foundations of Research Security

National Security Presidential Memorandum-33 (NSPM-33), issued by the White House on January 14, 2021, aims to protect U.S. Government-supported Research and Development (R&D) from foreign interference and exploitation. It mandates comprehensive research security programs at institutions receiving over \$50 million annually in federal R&D funding, covering four key areas: cybersecurity, foreign travel security, research security training, and export control training. In response, the University of...

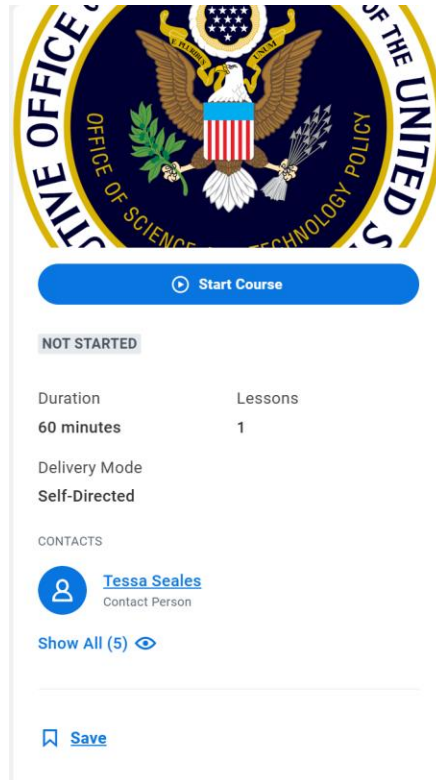

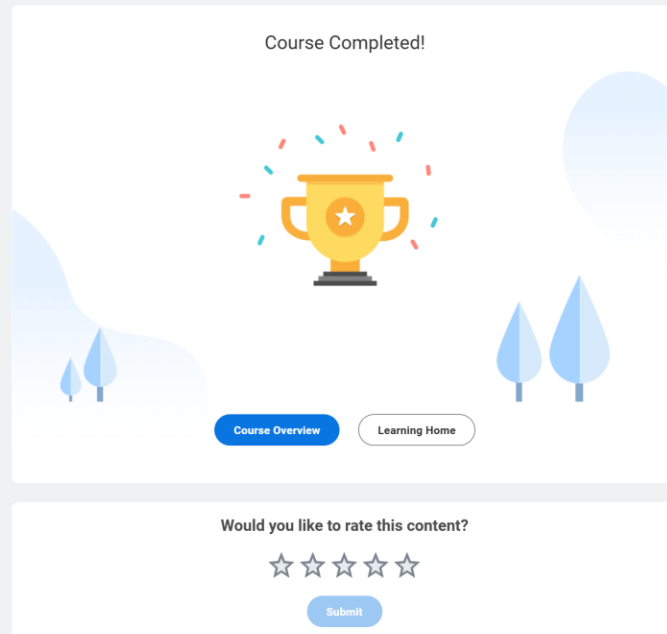

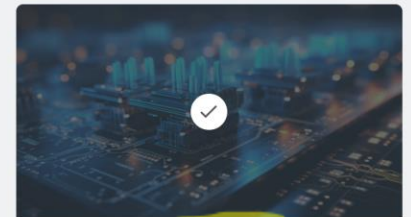
